Proceedings:

1. Minutes and Action Items Review

- Minutes of MSG meeting on 28 July 2017 pending to be circulated.

Action Items:

- Secretariat to circulate the minutes of previous MSG meetings within the week.

2. 2017 Final Review

Local Host Final Statistics

- Secretariat provided a brief update on behalf of the local host:
 - **Attendance** – 515 people attended on-site (including 177 walked-in)
 - **Online Registration** – Total 614 online pre-registrations (50% turn-up rate) including 120 from government representatives
 - **Actual demographic of on-site participants** – pending from local host
 - **Gender Statistics** – Panel speakers information are also included this year as an enhancement from 2016 report card. Statistics attached.

Discussions:

- Singh raised a question whether the majority of government representatives registered are from Thailand
- Wilson commended the good session attendance in general
- **Remote Participation** - Langdon-Orr queried about the low/unavailable number on remote participation. Singh commented that there is an impression of more remote participation. Secretariat will double check

with the local host of whether the AdobeConnect number has been fully incorporated. Singh raised the concern on the thin remote participation while quite some effort and minimum require has been put towards the local host, hence suggesting to consider more outreach to remote participants or even encouraging remote hubs. Okutani agreed that it may work for some economies. Hilyard added that there is also timezone issue to be considered.

- **Social Media** - Secretariat mentioned that a new twitter account was created at the closing plenary which could also be used to promote the activities of APRI GF and encouraged MSG members to share it with their community. Singh suggested to have a permanent link of a landing page on remote participation which could be circulated widely for remote participation of every APRI GF instead of promoting only just before the conference period.

Action Items:

Survey Responses Updates

- Fellowship Program – 17 responses received and deadline for submission is 15 Aug (Result Link: <http://igf.asia/2017fellowsurvey-result>)

- General Attendees Feedback – 52 responses received (Result Link: <http://igf.asia/2017surveyresult>)
- Highlights of the survey:
 - Majority of responses are from civil society and newcomers
 - Generally good feedback on the statistics but there were comments on the unstable Internet connectivity which the secretariat will work with the 2018 host to ensure a more stable Internet.
 - A high score of 4.55 is received for the lunch and coffee breaks
 - A lot of people attended 4-6 sessions.
 - Gender balance of speakers was one of the considerations during workshop selection yet we still need continuous improvement.
 - High score and genuine interest on the program and the new thematic roundtable of the opening plenary.
 - Cyber-security Role Play was rated most as the favourite session. This notes that a lot of participants enjoyed the interactive format.
 - Reinforcement of the purpose of the Synthesis Document is encouraged. Singh suggested that expectation management on-site is needed for newcomers or those joined in the middle of the town hall sessions.

Discussions & Comments:

- Wilson suggested to ask attendees to name a specific session and comment on the format and content directly to give more comprehensive information.
- Okutani agreed with Wilson. She also shared additional feedback that she heard from other participants which the thematic roundtable at the opening and the closing are good. She suggested to have balance on stakeholders next year on each themes for the roundtables. Okutani suggested to include the question on topic of interests and background in the survey to understand better on whether it's merely the alignment of interests or it's a genuine interesting session.
- Okuntani mentioned a remarks and positive feedback made by a private sector stakeholder that she invited to attend APriGF the first time.
- Okuntani suggested to set IPv6 as a requirement for future local hosts. Singh showed preference to include that. Chung agreed that we shall at least enquire about the connectivity of IPv6.
- Chen suggested to dedicate 1.5 hour to the Synthesis Document town hall session next year.

Action Items:

- Secretariat to send a reminder to all participants to collect more survey responses.

Synthesis Document 2017

- A total of 138 comments received online
- Drafting Committee had a call last week to prepare the intensive work to actually synthesize the Draft 1 based on the comments received on Draft 0. Volunteers are recruited to different sub-teams of each sub theme and a new Capacity Building theme was added in addition to the 4 sub-themes of APriGF 2017.

- Working Timeline:
 - 16 Aug Draft 1
 - 16 Aug Webinar 2
 - 16-31 Aug Public Comment 2
 - 8 Sep Draft 2 for Finalization
 - 13 Sep Publish Synthesis Document
- Note that the date for draft 1 has been shifted from 11 Aug due to the number of comments received.
- More dialogues are observed on the commenting platform this year instead of individual comments as observed in Taipei.

Discussions:

- Okutani commented that it is great to see the increased interest and more volunteers on the drafting team. Singh echoed that it is good to have more volunteers. Hilyard added that the Committee has been encouraging the fellows and other mailing list members to join.
- Singh asked for a clarification about the Drafting Committee membership and Secretariat confirmed that it is open to non-MSG members.
- Secretariat added that there are many volunteers for the Access sub-theme but not the security and digital economy ones.

3. IGF Geneva Workshop

- Secretariat updated that no substantive changes were made to the original submitted proposal but Nepal IGF representative is invited as a discussant in the roundtable.
- An NRI call is going to be held later in the afternoon to discuss about the NRIs collaborative session at IGF Geneva which the secretariat encouraged MSG members to join.

Discussions:

- Chen asked if there is a place that consolidates what NRIs are happening and the regular updates. Wilson shared the link:

- Secretariat added that there is an igf regional list for NRIs. A separate list has been set up for Asia Pacific as an action item from the NRI session at APiIGF Bangkok 2017.

4. 2018 Preparations

- 2018 local host confirmed that the government venue is available with a proposed date of 14 – 17 Aug 2018 (Tue-Fri). They are currently in talks with other regional organizations such as APNIC, ISOC and APT, etc for support.
- Secretariat suggested to shift the conference 1 day earlier since there are more incoming flights on Sunday instead.

- The MSG agreed that it is more convenient to start the Day 0 on Monday for attendees and therefore the new proposed dates will be 13 Aug (Mon) – 16 Aug (Thu). The 2018 local host confirmed that it is possible.
